PRISON RAPE ELIMINATION ACT (PREA)

Background

PREA was established in 2003 to address the problem of sexual abuse and sexual harassment of persons in the custody of U.S. correctional agencies. Major provisions of PREA include the development of standards for detection, prevention, reduction and punishment of prison/jail rapes. This Act applies to all public and private institutions that house adult or juvenile offenders and is also relevant to community based agencies. The Harris county sheriff's office has a zero tolerance policy on issues pertaining to sexual abuse and sexual harassment involving inmates and is working continuously to implement new policies, training requirements for staff and inmates, and developing standards for detection, prevention, reduction and punishment of rape.

PRISON RAPE ELIMINATION ACT (PREA)

DEFINITIONS

- UNFOUNDED- THE ALLEGATION IS FALSE OR NOT FACTUAL.
- SUBSTANTIATED- THE ALLEGATION IS SUPPORTED BY SUFFICIENT FACTUAL EVIDENCE.
- UNSUBSTANTIATED- THERE IS INSUFFICIENT FACTUAL EVIDENCE TO PROVE OR DISPROVE THE ALLEGATION.

PRISON RAPE ELIMINATION ACT (PREA)

ANALYSIS

- IN 2018, HCSO WAS PREPARED FOR THE 2019 PREA AUDIT OF A NEW FACILITY. THE HCSO COLLABORATED WITH THE HOUSTON POLICE DEPARTMENT TO ESTABLISH THE HARRIS COUNTY JOINT PROCESSING CENTER.
- THE HCSO CONTINUED TO TAKE EXTRA PRECAUTION TO KEEP YOUTHFUL OFFENDERS INCARCERATED AT HARRIS COUNTY FACILITIES SAFE. ALTHOUGH THIS STANDARD WAS NOT PASSED DURING THE 2017 PREA AUDIT, THE ORGANIZATION CONTINUES TO IMPLEMENT MEASURES INVOLVING YOUTHFUL OFFENDERS TO THE BEST OF ITS ABILITY.



PRISON RAPE ELIMINATION ACT (PREA)

ANALYSIS

- THE HCISO IS CONTINUING TO WORK WITH THE HOUSTON AREA WOMEN'S CENTER FOR INDIVIDUAL AND GROUP COUNSELING REGARDING SEXUAL ABUSE INVOLVING ALL INMATES. RECEIVING COUNSELING SESSIONS IS NOT BASED SOLELY ON SEXUAL ABUSE ALLEGATIONS WITHIN HCISO JAIL FACILITIES.

- THE HCISO COLLABORATED WITH THE HOUSTON AREA WOMEN'S CENTER AND THE MOSS GROUP TO CREATE A PROFESSIONALLY PRODUCED PREA EDUCATION VIDEO FOR STAFF AND INMATE PURPOSES.
